PRESENTATION

The PUREKUSTIK range is available in panels made of polyester fibers from the recycling sector (60% recycled material).

The PUREKUSTIK attenuates noise by absorbing sound waves in indoor spaces.

PRINCIPLE

Thanks to the high sound absorption values, better acoustics are created in rooms where noise reverberation is an issue.

Once a room is treated, the comfort and intelligibility of verbal exchanges in a room is reduced. The size of the fiber and the transformation process aim for optimal porosity and tortuosity for the absorption of acoustic energy.

Polyester wool does not contain any toxic substances. The material does not form dust and does not contain chemical binders. The material has excellent dimensional stability after cutting.


IMPLEMENTATION: CABINET OR ISLAND

The panels can be mechanically fixed or glued. The surface receiving the panel should be clean, free of oil, dust and grease. Always perform a test with the glue to ensure compatibility and adhesion while strictly following the bonding instructions provided by the manufacturer.

The panels can be installed using TECSOUND suspension kits (contact us). For optimal acoustic correction, please leave a spacing between the edges of the panels of 5 cm.

The material withstands temperatures from -30°C to 120°C

Polyester wool can be cut with a sharp ceramic knife, scissors, filament, band saw, or foam saw. Maintenance: The surface can be easily cleaned with a vacuum cleaner and a soft brush.



IMPLEMENTATION: ADHESIVE MODULES

The PUREKUSTIK range can also have a surface equipped with an adhesive. Protected by a silicone yellow film, it is thus possible to adhere the panel directly to its support.

The panels must be glued to clean, dry supports free of traces of oils, greases, dust or solvents. After removing the protective film from the adhesive, uniform pressure should be exerted for adhesion over the entire surface and to prevent the formation of air bubbles. Please note that once the adhesive is applied, the panel is no longer moveable.

ENVIRONMENTAL CHARACTERISTICS

The PUREKUSTIK range is manufactured without VOC or formaldehyde emissions: product classified A+ (ISO 16000) according to report no. 72153D and Öko-Tex 100 environmental label class 1 (ISO 17050-1) – report no. 1596. Recyclable product (100% PET)

SURFACE COVERINGS

- Addition of a black film on the surface, for water and oil repellent protection
- Addition of aluminum on the surface for a heat shield function (heat reflection)
- Available with a self-adhesive side
- Other options (digital printing, shapes and sizes) on request with minimum order

MODE OF APPLICATION AND STORAGE CONDITIONS

The ambient temperature during installation must be between 15 and 30°C. Products must be stored in enclosed and dry places, not subject to strong variations in humidity.

Storage and transport conditions:


- PUREKUSTIK panels must be stored indoors, protected from the elements
- No other product or object should be stored on top, the cartons are stackable between them.
